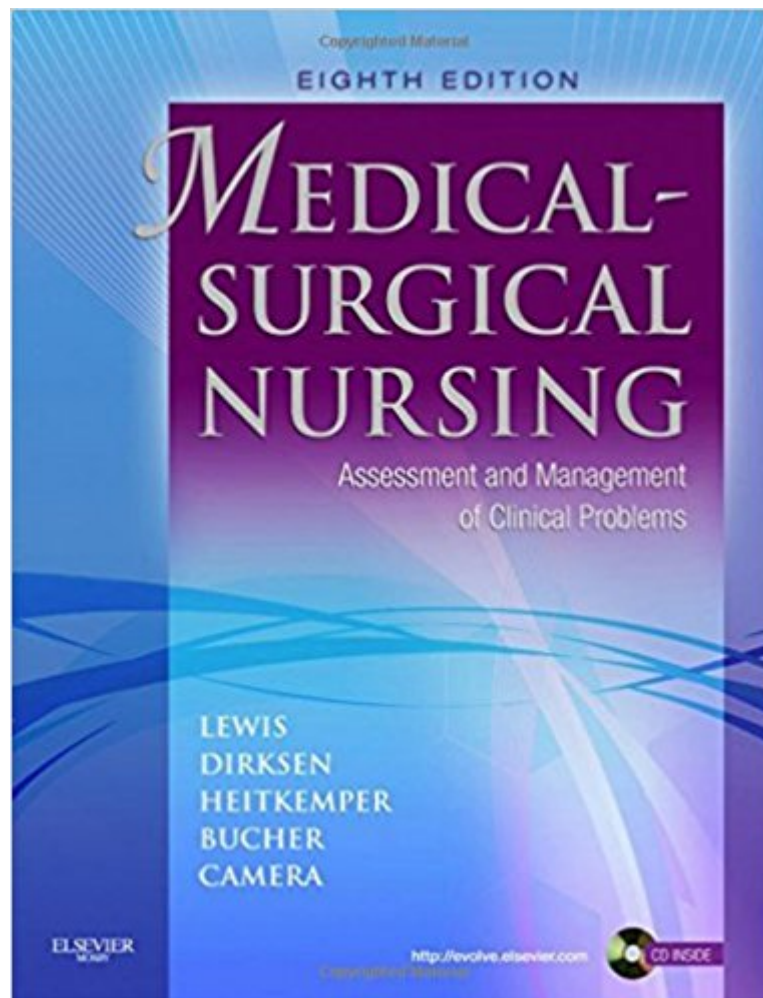

I have the single volume edition which is the same content but one binding- a bit heavier and the spine tends to lose it's rigidity from sheer weight. The two volume option is a good idea for being lighter and more sturdy. The book is technical, detailed and extensive. I found no typos unlike the first reviewer, and I'm a stickler for those things. The content is well-written, though challenging academically. I already had some pre-med Biology and Chem courses, which have helped. It could be more readable in terms of font and thicker paper. I'm sure the publisher had to choose the smaller type size and tissue-thin paper because the book was already so thick and heavy. However, any highlighting you do will show through the other side of the page. I wouldn't recommend buying a used edition if it has someone else's highlighting in it. It's also easy to rip the pages. Good use of color, though, and many clearly illustrated boxes highlighting and summarizing key points as well as denoting the nursing interventions and patient care plans. The pathophysiology portions are written at or close to the level of first-year medical school, in my opinion. A good way to ramp-up your technical knowledge and vocabulary if advanced practice nursing is your goal. I'm in a junior college program and feel this was a great help in getting me ready for my bachelor's, also. For me, the study guide was a must. See my review for the study guide. Each chapter has excellent review questions at the end, though not very many. The website also has additional NCLEX review questions, as does the workbook. These 3 sources do not duplicate review questions. The website also provides Chapter summaries that are excellent (like text outlines). You can print off the care plans provided in the chapters and there is a Spanish version for every care plan in the book. I have printed these and saved them to use with patients in the future.

In terms of content, Elsevier is great. However, they have neglected the most important tool for students - providing a generous supply of NCLEX practice test questions for each chapter. This is vital to pass the class AND the NCLEX. The Elsevier questions are too few, not customizable by chapter, and they are not NCLEX rationales. Elsevier could fix this problem quickly by reworking their online practice test format. Then, I would change this review from 1 star to 4! Until this happens, choose another publisher if you want your students to pass their class or the NCLEX.

I generally hate my textbooks but this one has a stronger hate. It is incredibly wordy and does not present information in an easy to learn manner. I use the reviews and rationales, the success series, and other guides over this book and was still able to attain a 97% in my classes. I know you have to buy it because the school requires it but this book was a bust for me.

I have three Med surg text books, including the Lemone and the Ignatavicius. By far, the Lewis Med surg Text book is the most concise, current, accurate and easy to understand of those that I have used. Secondly, this Lewis Med surg book gives the most relevant information without including a lot of unessential statistical data that other texts tend to do, and which may not be relevant for the NCLEX exam.

For all the nursing students who have struggled with issues related to ebooks for class such as pageburst by evolve etc... This book is a lifesaver for students studying medical-surgical nursing. Easy to find what you are studying. Tables are easily found and readable. Love this book! -and mine did come as a single book instead of 2 different books as some other people mentioned earlier...

BUT even if it had been two books that is still better than Ebooks! It improved my average test scores or 78-84 to 86-94! Good luck to everyone pursuing a career in the medical field!

Terrible text book. i used this for med-surg in a 2 year RN program. i rarely write reviews, but in this case i feel i have to warn new student nurses. NOT user/student friendly in the least. this is the type of book that requires A LOT of time being spent reading and re-reading in order to grasp the simplest concepts. NOT FOR BEGINNERS. I found it to be exceedingly torturous to read. unnecessarily dry, verbose, repetitive, and redundant. It seems as if the authors deliberately set out to prove what a VAST and intricate knowledge of the the human body they possess, and presented the information in a cryptic, hard to decipher manner. NOT a book for beginning nurses. TOO much pathophysiology (YES, it IS INDEED possible to overstress the minutiae of pathophysiology), presented in a disorganized and painfully BORING way. OVERWHELMING. let me add that i'm not shy when it comes to an intellectual or academic challenge. my A&P text book (Ken Saladin) was just as detailed, but it was a JOY to read!!! so well written and engaging. although all the proper scientific terminology was employed, in general the text was straightforward and in PLAIN ENGLISH. no incessant repetition because it wasn't needed. the concepts were presented such that i understood them on the first reading. shame on my nursing program for choosing this book and making our lives so much more difficult than was necessary.
