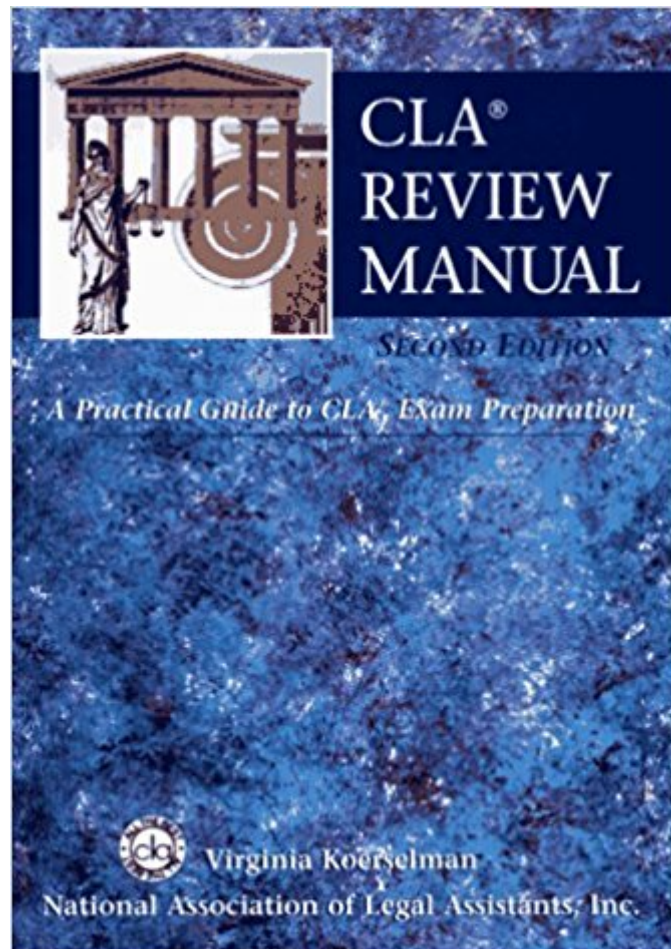

This book was my primary source when I was preparing for the CLA exam. Coherent, organized and thoughtful, it is a "must buy" for CLA candidates. Until my book was borrowed (and not returned) by another legal assistant, the manual served as a handy reference manual in my practice.

I participated in a study group for the CLA and my instructor had the newer green book. All they changed were the order of the identical Q's and perhaps the names in the scenarios from ex: Jane and Dick to Juan and Maria. The family law section addressing marriage as between a man and woman has been now changed to reflect the recent advancements in gay marriage in some states.

Then maybe his 3.9GPA Associate Degree might help him find a job in this field that has so far eluded him!

It is a very well-written book that will probably be very helpful in preparing me for my exam. However, I'm not sure yet because I took the cheap route and bought the 2nd edition when the 4th edition is actually out. We'll see but I'm very hopeful....

I feel like this book had me prepared to take my CLA exam. It was pretty comprehensive and easy to follow. The only complaint I have about the book is that it is quite expensive on the second-hand market. At the time I'm posting this, there aren't any new editions available, so buying a used one or a new one from the second-hand market (not) is the only way to get it. This really isn't the publisher's fault at all, but it is a deterrent in buying it. Even at the high prices, I feel like it was worth it to me. If you're looking for some prep help, I'd shell out the money and buy this book. It definitely gave me peace of mind going into the exam, and I think it covers a lot of great information in an easy to follow manner.
