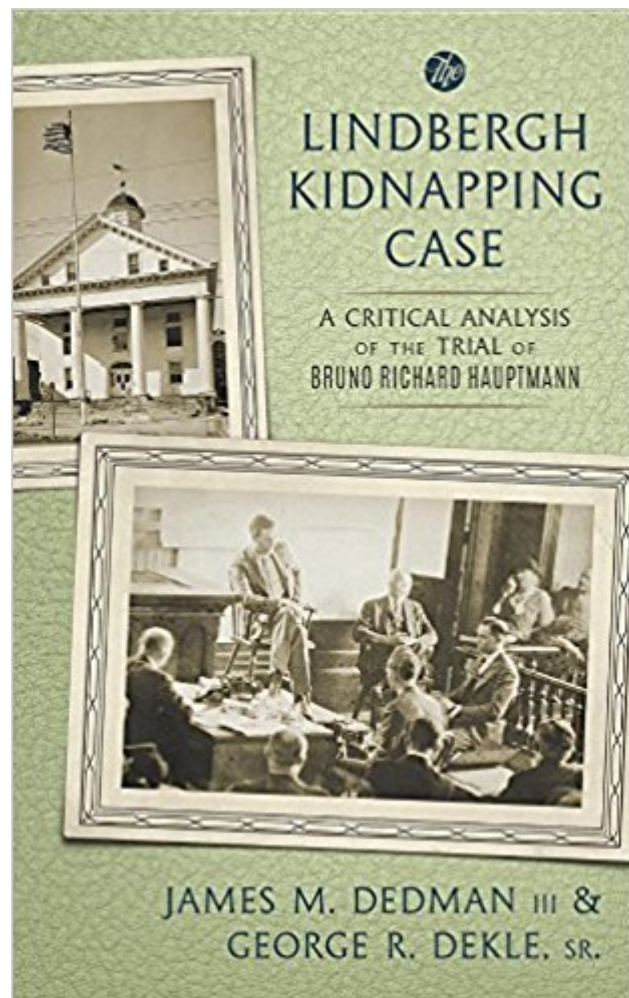

Lindbergh, Jr. touched off one of the most massive manhunts in the history of American crime detection and generated so much publicity at home and abroad that it was touted as the "Crime of the Century."
