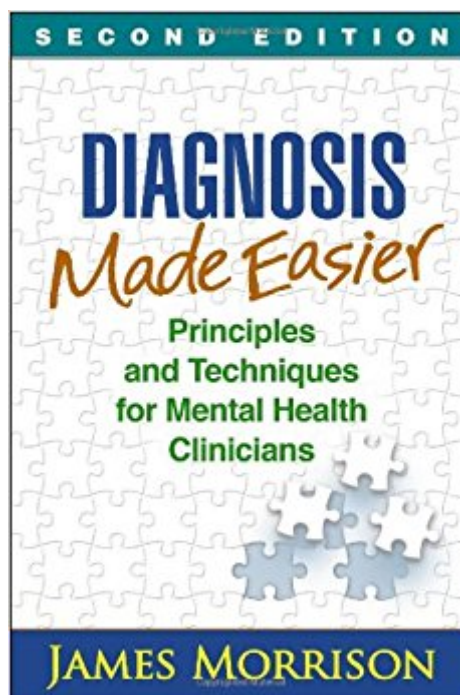

For an other wise solemn and serious subject, this writer makes his points clear and memorable by interspersing funny quips and reflections (which made me laugh) through out the book. Morrison makes learning about diagnosis interesting. His sense of humor helps make this book hard to put down.

Easy to read, has lots of case studies. I found the decisions trees very helpful. Be aware that (as the author himself says) he kind of straddles the DSM IV and DSM 5 (which makes sense, given it's publication date), so some of the terminology is technically outdated (though will likely still be used in practice for quite some time).

This book is better than his diagnosis made easy series. Hands down. No fluff, just what you need to know in a very concise and easy to understand manner. Buy this book!
